**Tuition Management**

Berean Christian School has contracted with FACTS Management Company to manage our tuition payments. FACTS Management Company serves over 4,000 schools nationwide and is the industry leader in tuition management for private and faith-based schools. Please know there will be an annual fee of \$43 for enrolling in FACTS. Once your account is set up, you will receive an initial invoice/statement from FACTS. It will list your total tuition and fee balance for the upcoming school year, along with instructions on how to enroll in a payment plan online. Scan the QR code and it will direct you to our FACTS online portal to begin.
