◆ **Physical Exam Form and Immunization Record** is required for ALL new students and students entering Kindergarten, 6<sup>th</sup> grade, and 9<sup>th</sup> grade.

◆ **Updated Immunization Record** is required at 4 years of age and 12<sup>th</sup> grade.

◆ **Dental Exam Form** is required for students entering Kindergarten, 2<sup>nd</sup> grade, and 6<sup>th</sup> grade.

◆ **Eye Exam Report** is required for students entering Kindergarten and those attending an Illinois school for the first time.

**\*\* These are state mandated requirements, and must be completed by Oct. 15<sup>th</sup> in order to remain in school. \*\***

**LATE FEE:** A \$25 late fee is applied to all late tuition payments. All tuition paid directly to BCS is due in full by the 1st day of each month and is considered late if not paid by the 5th of that month.

**RETURNED CHECK FEE:** A \$50.00 fee is charged for all returned checks.

*Monthly Tuition Payments made to the school office by check or cash will be charged a \$10.00 processing fee.*

**Tuition Management**

Berean Christian School has contracted with FACTS Management Company to manage our tuition payments. FACTS Management Company serves over 4,000 schools nationwide and is the industry leader in tuition management for private and faith-based schools. Please know there will be an annual fee of \$43 for enrolling in FACTS. Once your account is set up, you will receive an initial invoice/statement from FACTS. It will list your total tuition and fee balance for the upcoming school year, along with instructions on how to enroll in a payment plan online. Scan the QR code and it will direct you to our FACTS online portal to begin.

**Edgemont Bible Church is a non-denominational, fundamental, non-charismatic fellowship, believing:**

The whole Bible, consisting of the sixty-six books of the Old and the New Testaments, is verbally inspired of God and inerrant in the original writings, and is the supreme and final authority in faith and life.

In One Triune God, eternally co-existing in three Persons – Father, Son, and Holy Spirit – each eternal in being, identical in nature, equal in power and glory, and having the same attributes and perfections.

The Lord Jesus Christ, the eternal Son of God, became wholly man, without ceasing to be God, having been conceived by the Holy Spirit and born of the virgin, Mary, in order that He might reveal God and redeem sinful man. This in redemption was accomplished through His death on the cross, as a sinless representative, vicarious, substitutionary sacrifice; and our justification is made sure by His literal, physical resurrection from the dead. The Lord Jesus Christ ascended to heaven, and is now exalted at the right hand of God, where, as our High Priest, He fulfills the ministry of Representative, Intercessor, and Advocate.

Man having been created pure in the image of God is by his own sin fallen from grace and that, in consequence, all have sinned and are guilty and lost, and absolutely incapable of saving themselves by their own works.

We are saved solely by grace, through faith in the blood sacrifice, death, and resurrection of Jesus Christ, the Son of God.

It is the duty and privilege of every born-again believer to live in Spirit controlled obedience to the Word of God, to live at peace with all men, to develop harmonious relationships with all other believers, and to willingly participate in the process of being conformed to the image of Jesus Christ.

The whole universe and everything contained in it were formed by the voice of God in 6 literal 24-hour days.

The “blessed hope” is the pre-millennial, personal, imminent return of Christ for His saints, the Church, before the end of the seven-year tribulation period.
